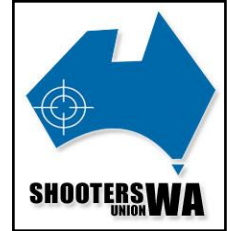

### MEMORANDUM OF UNDERSTANDING

The Shooters Union Australia Inc. (IA40707) and the Western Australian Firearm Owners Alliance Inc. (A1016823K) affirm that henceforth:

1. The Western Australian Firearm Owners Alliance Inc. is authorised to act as the sole branch of the Shooters Union Australia Inc. within the state of Western Australia and shall be referred to as 'Shooters Union Western Australia'.
2. All subscriptions paid to Shooters Union Western Australia shall remain the sole property of the Western Australian Firearm Owners Alliance Inc. acting as Shooters Union Western Australia and the Shooters Union Australia Inc. shall have no claim upon them.
3. The Western Australian Firearm Owners Alliance Inc. acting as Shooters Union Western Australia shall be considered a full member of the Shooters Union Australia Inc. with full voting rights under section 5 (a) (i) of the Shooters Union Australia Inc.'s constitution.
4. Financial members of the Western Australian Firearm Owners Alliance Inc. acting as Shooters Union Western Australia shall be considered associate members of the Shooters Union Australia Inc. and shall have no voting rights within the structure of the Shooters Union Australia Inc.
5. The Western Australian Firearm Owners Alliance Inc. acting as Shooters Union Western Australia shall be free to address matters pertaining to private firearms ownership within the state of Western Australia without recourse to the Shooters Union Australia Inc.
